The International Arbitration Court under intergovernmental international organizations, (hereinafter referred to as "the IAC"), represented by the Chairman _____, authorized by the IAC Regulations, and

the _____

hereinafter jointly referred to as "the Parties",

based on the provisions of the United Nations Convention on the Recognition and Enforcement of Foreign Arbitral Awards (New York, 10 June 1958), European Convention on International Commercial Arbitration (Geneva, April 21, 1961), for the purpose of developing arbitration proceedings, economic entities of participants of integration associations, as well as for better performance of their own statutory goals and objectives, have signed this Agreement in order to ensure the work of the IAC as follows:

I. Rights and obligations

Based on the fact that the Parties to the Agreement are non-profit organizations established with the aim of improving economic, legal, scientific, informational and technological conditions, the Parties agreed to share functional responsibilities to ensure the quality and continuous functioning of the IAC, on a voluntary basis by sharing distributing rights and duties as follows:

1. 1 Rights and obligations of the _____

1.1.1 _____ is a basic organization that provides the resources, intellectual development and legal rights available to the employees of this organization in order to ensure the work of the court, based on the legal framework of Jersey legislation of the country of location and international agreements.

1.1.2 _____ provides, if necessary, participation in the court of specialists and organizations with special skills and knowledge, participates in the work of a qualified Commission, under a separate agreement with the Chairman of the IAC.

1.1.3 _____ has the right to receive reports on the work of the court.

1.2 Rights and responsibilities of IAC

1.2.1 The IAC provides legal proceedings and administration of the court.

II. Financing.

The work of the IAC is financed from the funds received as a result of dispute resolution. The financial participation of the Parties is determined by a separate agreement.
